## **Course:** *E211 - ESF #14 FEMA/State Long-Term Community Recovery (LTCR)*

**Date:** April 19 – 22, 2010

### **Course Description:**

This course is designed to provide a solid foundation for the practical application of ESF #14 policies, procedures and tools in order to ensure consistent and effective field operations.

### **Course Goal:**

The goal of this course is to introduce the ESF #14 – Long-Term Community Recovery (LTCR) concept to managers, key field operations staff, emergency management personnel and response and recovery personnel from various components. This course is designed to enable the target audience to convene, coordinate, implement and deactivate ESF #14 – LTCR.

Upon completion of this course, participants will be able to:

1. Explain the purpose, necessity and timing of ESF #14 - LTCR
2. Explain the phases of ESF #14 – LTCR field operations and corresponding tools.
3. Explain the framework of a disaster – specifically ESF #14 management strategy.
4. Demonstrate via a disaster simulation how to activate, assemble, manage and deactivate ESF #14 – LTCR.

### **Prerequisite:**

National Incident Management System (NIMS) baseline, Incident Command System (ICS) courses including: ICS100, 200, 700, 800 and IS-814 Long Term Community Recovery.

**Course Length:** 4 full days. Travel days are Sunday and Friday

### **Target Audience:**

This course is designed for primary and secondary target audiences; primary audience includes FEMA, Primary Agencies, Support Agencies and States. Secondary audience includes; partners and stake-holders in the LTCR process including; Local government, private sector, community and Faith-based organizations and Regional planning organizations.
