Location:

This course will be delivered at the National Emergency Training Center in Emmitsburg, MD.

Course Description:

This Emergency Management Institute (EMI) course provides state, local, tribal, and territorial staffs with an overview of FEMA's Public Assistance (PA) Program, process, and policies. Course topics include introduction to program laws, regulations, policies, the PA process, grants management, eligibility, hazard mitigation in the PA Program, compliance with other Federal laws and regulations, and project formulation.

Target Audience:

The target audience for this course includes state, local, tribal, and territorial government personnel responsible for administering Public Assistance grants.

To Apply:

To apply for this course, go to the National **Emergency Training Center Online Admissions** Application.

Registration Supervisor Approval:

The Application Endorsement Screen requires the input of a supervisory email address. Once submitted, the application will be forwarded to that individual for approval. Once approved, the application will then route to the NETC Admissions Office.

Travel and Housing Information:

Upon acceptance into the course, NETC Admissions will mail out an Acceptance Letter and Welcome Package outlining travel information, NETC shuttle services, lodging and other logistics. Lodging is provided for course participants on the NETC campus. Participants staying overnight on campus are required to purchase a meal ticket for the duration of the training activity. Notify the NETC Transportation Office at least 2 weeks prior to the course date to reserve a shuttle seat. Details for the above are in the Welcome Package.
