# National Emergency Management Advanced Academy (NEMAA) Overview/FY19 Application Process

Update - Application deadline extended to June 8, 2018/Course dates released

#### Purpose:

To provide an overview of the National Emergency Management Advanced Academy (NEMAA) program and the Federal Fiscal Year (FY) 19 application process.

#### **Program Description:**

The <u>National Emergency Management Advanced</u>
<u>Academy</u> is a component of the <u>Emergency</u>
<u>Management Professional Program</u> (EMPP).

NEMAA reinforces the qualities needed to lead emergency management programs, provides relevant management theories and concepts, and uses case studies to enhance emergency management (EM) skill sets. NEMAA participants work within a collaborative environment on projects and establish a network of peers.

NEMAA is designed for mid-level managers/professionals with a minimum of three (3) years' experience in an Emergency Management (EM) position who want to advance their skills. Participants learn skills critical to performing EM responsibilities, such as program management and oversight, effective communication at all levels, integrated collaboration, and strategic thinking.

NEMAA provides participants the opportunity to demonstrate their critical thinking ability through a guided NEMAA Paper. Students apply the key learning concepts from the NEMAA curriculum relative to their own strengths and weaknesses, their organizations, and their own performance environments.

#### Target Audience:

NEMAA is designed for emergency management professionals with a minimum of three years' experience directly with an Emergency Management (EM) organization or three years' experience with a significant role directly connected to the Profession of Emergency Management or a recognized EM organization; to include, but are not limited to Public Health, Higher Education, Medical, and Private Sector organizations or companies with a role in Emergencies and Disasters.

- Employed or directly connected (ex. Volunteer) with Emergency Management (EM)
- Examples: Federal, Military, State, Local, Tribal, Territorial and Consortium EM Agencies
- Directly Connected with the Profession of Emergency Management (EM) or a Recognized EM Organization
- Examples: Public Health, Higher Education, School Systems, NGOs, Private Sector Business Continuity/EM

## Update-Application Process (February 1 – June 8, 2018):

Completed application packets will be reviewed by a formal selection board. The application window is <u>February 1 - June 8, 2018</u>, with selections in June and announcements in July.

The FY19 EMI course schedule is released and the selected participants will be placed in one of the two cohorts by the selection panel.

#### Cohort I:

- E0451 October 15-19, 2018
- E0452 January 28-February 1, 2019
- E0453 April 8-12, 2019
- E0454 August 5-9, 2019

#### Cohort II:

- E0451 October 22-26, 2018
- E0452 February 4-8, 2019
- E0453 April 15-19, 2019
- E0454 August 12-16, 2019

The selection panel will consider your request for a specified cohort if identified in your cover letter as long as the whole community of the cohort is met.

#### **Application Selection Criteria:**

Applications will be evaluated based on recommended prerequisites to include:

- At least three (3) years' experience in an EM position;
- Project and working group leadership;
- Substantial continuing service commitment; and
- Whole community representation.

**NOTE**: Completion of the Basic Academy is **NOT** a pre-requisite to apply for the NEMAA.

#### **Classroom Requirements:**

The NEMAA Program consists of four (4) resident courses, each **five (5) days** in length. Attendance at each course is required and must be attended in sequential order (listed below) during FY19. An updated list of course dates will be sent to applicants accepted into the Program. The courses are not offered individually.

**E0451** Advanced I – A Survey of Advanced Concepts in Emergency Management

**E0452** Advanced II – Assessment and Application of Professional Style in Emergency Management);

**E0453** Advanced III – Advanced Concepts and Issues in the Emergency Management Organization; and

**E0454** Advanced IV - Advanced Concepts and Issues in the Emergency Management Community and Profession).

#### How to Apply:

Each application must include the following five items submitted in order 1-5:

- A General Admissions Application Form or <u>FEMA Form 119-25-1</u> (Item 9.a. on the form should state "E0451 National Emergency Management Advanced Academy").
- The applicant's signed <u>commitment</u> <u>statement</u> indicating their commitment to complete the entire program to include the four resident courses at EMI and the NEMAA Paper.
- 3. A <u>resume</u> not to exceed two (2) pages (no required format).
- A <u>cover letter</u> from the applicant (not to exceed one (1) page) requesting admission to the program and specifying the applicant's qualifications and perceived expectations of the program (no required format).
- 5. An Advanced Academy Questionnaire.
- 6. A <u>letter of recommendation</u> from your Supervisor.
