Course Date:

February 25-27, 2019

Course Length:

This course is 3 days in length. Class times generally run from 8:00 a.m. to 5:00 p.m. each day.

Location:

Emergency Management Institute (EMI)
National Emergency Training Center (NETC)
Emmitsburg, Maryland

Course Description:

In this course students will gain the tools to engage with the whole community and help community groups move beyond basic awareness, and truly move the needle to resiliency. By the end of class, students will build a roadmap to resiliency customized to their community.

Course Goal:

To provide students with a roadmap for establishing a community resilience coalition and to encourage community leaders to make resiliency gains within the unique circumstances of their jurisdiction.

Prerequisites:

Students should have a basic understanding of the fundamentals of emergency management and community preparedness.

Continuing Education Units (CEU's):

EMI awards 1.8 CEUs for completion of this course.

Target Audience:

The target audience for this course includes community stakeholders interested in disaster resilience, as well as new emergency management professionals who support or implement inclusive emergency management, community disaster planning, preparedness activities, and community outreach at the state and local levels.

To Apply:

Complete a FEMA Form 119-25-1, General Admissions Application, with student signature and signature of supervisor or sponsoring agency official. Submit the application through the State Emergency Management Training Office. FEMA Regional employees should submit their application to their Regional Training Manager (RTM). Tribal representatives can submit their application directly to NETC Admission Office. Tribal government representatives or Federal government employees DO NOT need to submit applications through the State Emergency Management Training office or FEMA Regional Office. Notice to Applicants for EMI courses:

Individuals applying for EMI classes will be required to register using the FEMA Student Identification (SID) number. This number will be used in place of the Social Security Number (SSN) on your application form. The SSN is no longer required.

How do I obtain my FEMA SID number?

Step 1. <u>To register</u>, go to https://cdp.dhs.gov/femasid

Step 2. Click on the "Need a FEMA SID" button on the right side of the screen.

Step 3. Follow the instructions and provide the necessary information to create your account.

Step 4. You will receive an email with your SID number. You should save this number in a secure location.

NATIONAL EMERGENCY TRAINING CENTER (NETC) CAMPUS ACCESS – REAL ID ACT STANDARDS

Does your ID meet the Real ID Act standards? Anyone entering the National Emergency Training Center (NETC) campus is required to show valid photo identification that meets REAL ID Act standards. The purpose of the REAL ID Act is to stop terrorists from evading detection by using false identification. Check to see if your state is compliant at https://www.dhs.gov/current-status-states-territories.

If your driver's license does not meet the requirements of the REAL ID Act, you will need to bring one of the following acceptable forms of identification:

- A valid U.S. passport or passport card.
- A valid federal employee, military, or veteran ID card.
- A valid state-enhanced driver's license (Contact your state's motor vehicle department for availability).

Students from non-compliant states (a regular driver's license from these states will not be accepted) who do not possess any acceptable form of identification may request a National Crime Information Center (NCIC) check from the NETC Security Office. Note: This is a one-time NCIC check; a successful NCIC check is valid for 180 days; within the 180 day time-frame a student is expected to obtain a compliant form of identification).
