Course Description:

FEMA recognizes the need to tie training programs to an established set of emergency management competencies and to a Career Development Program through a progressive training and education system that includes the entry-level Academy, called the National Emergency Management Basic Academy. Training objectives for this course are based on the newly established emergency manager competencies that the National Emergency Management Association; the International Association of Emergency Managers; and state, local, territorial, and tribal emergency management professionals have established in coordination with EMI.

The following topics in emergency management are covered in this course: history; legal issues; intergovernmental and interagency context; influencing and organizing; social vulnerability issues; managing stress; collaboration, preparedness, and team-building; mitigation, response, prevention, and protection; ethical

decision-making; recovery; technology; administration; and the future.

Course Goal:

At completion of this course, students will have a basic knowledge of the history of doctrine and authorities of emergency management, the role of the emergency manager, and an overview of all hazards.

Prerequisites:

Six online Independent Study courses are required as prerequisites to the classroom courses. All six must be completed before submitting an application for E/L0101:

- <u>IS-100</u> (any version) Introduction to the Incident Command System (ICS)
- IS-120.a An Introduction to Exercise
- <u>IS-200</u> (any version) ICS for Single Resources and Initial Action Incidents
- <u>IS-230.d</u> Fundamentals of Emergency Management
- <u>IS-700</u> (any version) National Incident Management System (NIMS), An Introduction
- <u>IS-800.b</u> National Response Framework, An Introduction

Cost:

There is no fee for the course. Food & transportation costs are the responsibility of the

participant. Limited Lodging is available for the nights of July 7-12, 2019 and July 28-August 2, 2019 for public sector personnel. You are eligible for lodging if your residence and official work station are more than 50 miles from the SPTC and you are public sector personnel from New York State. Lodging is not available for federal employees, private industry, or out-of-state participants. You must be enrolled in the course and have received lodging confirmation from the SPTC before arriving at the Center, or your lodging will not be covered.

You must attend all required course sessions to be eligible for funding. Failure to attend all sessions will result in the registrant being responsible for all expenses incurred.
