Course Length:

This course is 2 days in length. Class times generally run from 8:00 a.m. to 5:00 p.m. each day.

Location:

Emergency Management Institute (EMI) National Emergency Training Center (NETC) Emmitsburg, Maryland

Course Description:

This course trains participants to post financial transactions to the Integrated Financial Management Information System (IFMIS). Participants will be instructed by an expert system user about transactions for the following: disaster assistance, travel advances, receiving reports, invoices, expenditures, approvals, reports, and more. Successful completion of the course is required before access to the system will be aranted.

Course Goal:

To provide participants with the knowledge to post financial transactions to the Integrated Financial Management Information System (IFMIS).

Target Audience:

The target audience for this course is FEMA Staff that is responsible for posting, researching, and viewing financial transactions in the Federal Emergency Management Agency's (FEMA) Integrated Financial Management Information System.

Notice to Applicants for EMI courses:

Individuals applying for EMI classes will be required to register using the FEMA Student Identification (SID) number. This number will be used in place of the Social Security Number (SSN) on your application form. <u>The SSN is no</u> <u>Ionger required</u>.

How do I obtain my FEMA SID number?

Step 1: Register (https://cdp.dhs.gov/femasid)

- Step 2: Click on the "Need a FEMA SID" button on the right side of the screen.
- Step 3: Follow the instructions and provide the necessary information to create your account.
- Step 4: You will receive an email with your SID number. You should save this number in a secure location.

NATIONAL EMERGENCY TRAINING CENTER (NETC) CAMPUS ACCESS – REAL ID ACT STANDARDS

Does your ID meet the Real ID Act standards? Anyone entering the National Emergency Training Center (NETC) campus is required to show valid photo identification that meets <u>REAL ID Act</u> <u>standards</u>. The purpose of the REAL ID Act is to stop terrorists from evading detection by using false identification. Check to <u>see if your state is</u> <u>compliant</u> (https://www.dhs.gov/current-statusstates-territories).

If your driver's license does not meet the requirements of the REAL ID Act, you will need to bring one of the following acceptable forms of identification:

- A valid U.S. passport or passport card.
- A valid federal employee, military, or veteran ID card.
- A valid state-enhanced driver's license (Contact your state's motor vehicle department for availability).

Students from non-compliant states (a regular driver's license from these states will not be accepted) who do not possess any acceptable form of identification may request a National Crime Information Center (NCIC) check from the NETC Security Office. Note: This is a one-time NCIC check; a successful NCIC check is valid for 180 days; within the 180 day time-frame a student is expected to obtain a compliant form of identification).

Submit the following information to jason.cawthon@fema.dhs.gov in a passwordprotected document at least three weeks before your class:

- Your full name
- Date and place of birth
- Social Security Number

Students arriving at the NETC campus without a compliant ID or a successful NCIC criminal history check will be sent home at their own expense without receiving a stipend reimbursement.
