## Course: E0210 Recovery from Disaster: The Local Community Role (Pilot)

#### Course Date:

March 16 - 19, 2020

#### **Travel Dates:**

March 15 and March 20, 2020

#### **Course Length:**

This course is 4 full days (8:30 am - 5 pm daily)

#### Location:

Emergency Management Institute (EMI) National Emergency Training Center (NETC) Emmitsburg, Maryland

#### **Course Description:**

This pilot course will test newly updated content that addresses concepts in disaster recovery and the latest guidance on recovery planning. Participants will either assess their own recovery plan or a sample against this national planning guidance. Following that, participants will discuss how a disaster recovery effort can be organized, managed, and led along with the types of challenges faced by recovery managers. Scenario activities throughout the course give participants the opportunity to target information strategies, address local capabilities and challenges, and analyze experiences from various communities that have experienced disaster.

#### **Course Goals:**

- 1. Increase participants' knowledge of local government responsibilities and challenges associated with disaster recovery.
- 2. Prepare participants to analyze the need for, develop, revise, and/or implement a predisaster recovery plan.
- 3. Provide a forum for discussion of "lessons learned" in disaster recovery at the local level.

#### NATIONAL EMERGENCY TRAINING CENTER (NETC) CAMPUS ACCESS - REAL ID ACT **STANDARDS**

Does your ID meet the Real ID Act standards? Anyone entering the National Emergency Training Center (NETC) campus is required to show valid photo identification that meets REAL ID Act standards. The purpose of the REAL ID Act is to stop terrorists from evading detection by using false identification. Check to see if your state is

compliant at https://www.dhs.gov/current-statusstates-territories.

If your driver's license does not meet the requirements of the REAL ID Act, you will need to bring one of the following acceptable forms of identification:

- A valid U.S. passport or passport card.
- A valid federal employee, military, or veteran ID card.
- A valid state-enhanced driver's license (Contact your state's motor vehicle department for availability).

Students from non-compliant states (a regular driver's license from these states will not be accepted) who do not possess any acceptable form of identification may request a National Crime Information Center (NCIC) check from the NETC Security Office. Note: This is a one-time NCIC check; a successful NCIC check is valid for 180 days; within the 180-day time-frame a student is expected to obtain a compliant form of identification).

Submit the following information to Jason.Cawthon@fema.dhs.gov in a passwordprotected document at least three weeks before your class:

- Your full name
- Date and place of birth
- Social Security Number

Students arriving at the NETC campus without a compliant ID or a successful NCIC criminal history check will be sent home at their own expense without receiving a stipend reimbursement.
