#### **Course Dates:**

October 4-8, 2021

#### **Travel Dates:** October 3, 2021 and October 9, 2021

#### **Course Length:**

This course is 5 days in length.

#### Location:

Emergency Management Institute (EMI), National Emergency Training Center (NETC), Emmitsburg, Maryland

#### **Course Description:**

Deliberate planning enables a jurisdiction to mitigate loss and improve outcomes from hazards, threats, and risks. The Planning Practitioner Program (PPP) mission is to improve the capabilities of emergency management planning personnel in planning program management and in every phase of the overall planning process. To be effective, active planners need proven planning theories and practice in the six steps of the planning process. This instructorled course allows planners to further develop their knowledge, skills, and abilities to perform effectively as Lead Planners and improve both the quantity and quality of planning conducted at the local, Tribal, State, and Federal levels of government.

#### Course Goal:

The goal of this course is to establish knowledge and skills for a baseline deliberate planner who can synthesize information and make appropriate decisions and introduce advanced deliberate planning theories and how they transcend discipline-specific planning positions.

#### **Prerequisites:**

Applicants must complete all 9 pre-requisites OR have graduated from the EMI Basic Academy.

- 6. IS-0800: National Response Framework (NRF), An Introduction
- 7. IS-0240: Leadership and Influencing
- 8. IS-0241: Decision Making and Problem Solvina
- 9. IS-0242: Effective Communication

#### Target Audience:

This course is for experienced individuals with responsibilities in deliberate planning programs. Ideal candidates will have some experience (1-3 years) with emergency planning activities to include: Appointed emergency managers and emergency management staff from local, State, tribal, and Federal emergency management offices; Senior public safety or political appointees who have taken positions in the emergency management field; personnel serving in various emergency management disciplines (e.g., law enforcement, fire, public works, and public health) who desire or require further training in deliberate planning.
