Course Description:

The Basic Academy Train-the-Trainer consists of 2 days of discussions about course objectives, how to set up and facilitate the class, time management, and other general topics. The last 3 days consist of student teach-backs that describe activities and exercises to demonstrate students' grasp of the Basic Academy course subject matter.

All curriculum content of the Basic Academy courses is covered in the Train-the-Trainer to support a training experience that combines knowledge of all fundamental systems, concepts, and practices of contemporary emergency management. The Academy provides shared experiences of adult learners and skillful instructors, resulting in a solid foundation upon which to become a qualified Basic Academy instructor.

Course Goal:

The goal of the Basic Academy Train-the-Trainer is to provide a sound and consistent basis for new instructors to learn to teach foundational concepts

of emergency management and develop skills in planning, exercises, and public information and warning.

Prerequisites:

Participants of the course have met the following selection requirements:

- Five years of experience in Emergency Management
- Three years of classroom training experience in adult learning

Also, it is recommended to complete the Basic Academy curriculum before taking this course as most of the host training managers require before instructing:
