Course Description:

This course will expand on the concepts of exercise evaluation and improvement planning that were introduced in the Homeland Security Exercise and Evaluation Program (HSEEP) course. Students will learn concepts on establishing an exercise evaluation program, gathering evaluation data effectively during exercises, and implementing and tracking improvements as part of a Continuous Improvement Program within their organization.

Course Goal:

This 4-day course will assist exercise evaluators and exercise program managers on their path to the Master Exercise Practitioner Program or help them to develop the skills needed for their current positions.

Course Objectives:

- Explain why exercise evaluation is important for community preparedness.
- Describe how to develop an effective exercise evaluation program.
- Select and modify evaluation tools (Exercise Evaluation Guides (EEGs), evaluation plans, collection analysis plans, etc.) to collect the desired exercise performance data.
- Develop the components of an effective After-Action Report/Improvement Plan.

Course Length:

The E/K0131, Exercise Evaluation and Improvement Planning Course, is 4 days in length.

Course Location:

- **E0131** is an in-person, instructor-led course held at the Emergency Management Institute (EMI), National Emergency Training Center (NETC), in Emmitsburg, Maryland.
- **K0131** is conducted virtually and is instructor-led. The log-in information will be provided by the Course Manager approximately 1–2 weeks prior to the class start date.
