IS-0245.c: Introduction to the Federal Priorities and Allocations System

Course Dates:

The revised course is now available online as of August 9, 2024.

Course Length:

The overall time to complete the course is about 1 hour.

Course Description:

This course seeks to educate and demonstrate familiarization of the Defense Production Act (DPA) and the Federal Priorities and Allocations System (FPAS) procedures, which are the primary source of Presidential authorities used to expedite and expand the supply of critical resources from the private sector in support of civil activities. DPA authorities are available to support: emergency preparedness activities conducted pursuant to Title VI of the Stafford Act; protection or restoration of critical infrastructure; and efforts to prevent, reduce vulnerability to minimize damage from, and recover from acts of terrorism within the United States.

Course Objectives:

Upon completing this course, the participant will be able to:

- Describe what the FPAS is.
- Describe what Rated Orders are.
- Explain Priorities Authority.
- Identify the FPAS Procedures.
- Describe Special Priorities Assistance (SPA).
