## L0110: National Emergency Management Basic Academy Train-the-Trainer

#### **Course Dates:**

December 9-13, 2024

#### **Travel Dates:**

December 8 and December 14, 2024 (For those not in the local commuting area.)

#### **Course Length:**

This course is 5 days in length.

#### Location:

GOHSEP - Governor's Office of Homeland Security & Emergency Preparedness, 7667 Independence Blvd, Baton Rouge, LA 70806.

#### **Course Description:**

The E/L0110: National Emergency Management Basic Academy (Basic Academy) Train-the-Trainer course consists of a 5-day learning experience intended to provide training instructors with a standardized curriculum for all training programs, and to establish a career development training program for the emergency management profession.

The course consists of 2 days of discussion about course objectives, how to set up and facilitate the class, time management, and other general topics. The last 3 days consist of student teachbacks that describe activities and exercises to demonstrate the students' understanding of the course subject matter.

All curriculum content of the Basic Academy is covered in the Train-the-Trainer course to support a training experience that combines knowledge of all fundamental systems, concepts, and practices of contemporary emergency management. The Basic Academy provides shared experiences of adult learners and skillful instructors, resulting in a solid foundation upon which to become a qualified Basic Academy instructor.

#### Course Goal:

The goal of the Basic Academy Train-the-Trainer course is to provide a sound and consistent basis for new instructors to learn to teach foundational concepts of emergency management and develop skills in planning, exercises, and public information and warning.

#### Prerequisites:

Starting October 1<sup>st</sup>, 2024, completion of the <u>IS-13: EMI Conduct and Behavior</u> course will be compulsory before participating in any <u>NDEMU training</u> at the NETC Campus. It's important to note that this course and exam are not required annually; they only need to be completed once. This course will be treated as a mandatory prerequisite for all courses.

- Documentation of at least 3 years' experience teaching emergency management to adults
