Community Risk, Vulnerability, and Resilience Data Module *Tari Martin, National Alliance for Public Safety GIS Foundation*

In the fall of 2020, the FEMA Higher Education (HiEd) Program funded the development of an academic module to explore the factors that may relate to community resilience. The module aimed to provide a mechanism for future emergency management professionals to practice interrogating data such as community factors and their relevance to community resilience. Materials developed were to provide background into the various applications in Emergency Management where community risk assessment data and analytics play an integral role; a high-level description of available indices and indicators; a deeper dive into FEMA's Resilience Analysis and Planning Tool (RAPT), and examples from real-world use cases by the community. The focus of the module and the recent work by National Alliance for Public Safety GIS (NAPSG) Foundation were a natural fit.

The module includes a facilitator guide, hands-on activity, (2) self-guided tutorials, and a supplemental resource guide to support further inquiry. The facilitator guide is designed to lead a discussion on how community functions, including organizational, social, and infrastructure, relate to community risk, vulnerability, and resilience. Students review community impacts from real-world disasters and learn about innovations from across the country to build resilience and tackle equity issues. Students gain insights into how indices are created and FEMA's process for identifying commonly used community resilience indicators in multiple indices. Finally, the self-guided tutorials allow students to use GIS to interrogate risk, vulnerability, and resilience data to support common emergency management workflows. In the first tutorial, students learn how communities identify their risk for hazards, explore publicly available data to support impact analysis, and practice translating that data into preparedness and mitigation strategies. In the second tutorial, students learn to use Community Resilience Indicator Analysis (CRIA) and the tools within RAPT to develop targeted communication strategies informed by the characteristics of a community.

We know that while different populations may be at risk to the same negative effects of disasters, "their actual vulnerability is dependent on their socio-economic conditions, civic and social empowerment, and access to mitigation and relief resources" (United Nations, 2016). Indices and tools such as GIS, can aid state, local, tribal and territorial (SLTT) governments in developing data-driven science-based approaches to inform plans and policies that build community resilience, focusing on the most vulnerable. Furthermore, as data and tools become more readily available to support the practitioner community, resources that enable the intended audience to leverage them as appropriate and with ease will aid in their efficient and proper use.

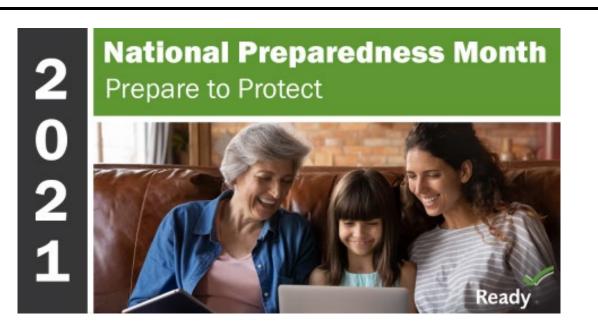
