Disaster and Emergency Management (DEM) Cases Repository Development & Special Collections *Jacob Fast, Antoine B. Richards, Jane Kushma, David Thornton*

The utilization of case studies in Disaster and Emergency Management (DEM) has a rich history across professional practice, research, and academic pursuits. Although there is little standardization in case study development and composition, the application of case studies to teaching is common. In order to best make use of case studies, it is critical to first locate and identify the resources.

The purpose of the DEM Teaching Cases Repository project is to provide a continually updated database of case studies related to disaster and emergency management. The project was designed to create a snapshot of scholarly articles that might be suitable for teaching cases in DEM curricula, beginning in 2017 and continuing through the present offerings. More than 70 journals were identified that could be useful in providing hazards and disaster-related articles. Each journal was scoured to identify specific articles that followed a case study format, using a combination of title and keyword recognition as well as examination of each article that focused on specific events, emergencies, hazards, disasters, and catastrophes. This manual search identified 1,116 articles. The 2017-2020 date range was selected in order to provide a sufficient pool of resources representative of the current body of knowledge and best practices in the field. Upon identification, each case study was subsequently classified and categorized according to several dimensions, including: Author(s); Publication Year; Title; Journal; Hazard(s); Specific Event; Country; Emergency Focus Area (e.g. Mitigation, Preparedness, Response, Recovery, Risk, Resilience, etc.); Key Terms or Words; Full Citation; and Direct Link to the Article. The next step in the project was to convert the information associated with the articles into a searchable database. Each dimension listed above was converted into either a searchable field or a drop-down menu of options to enable users to find cases that would be most beneficial to their needs. The database will continue to be updated and refined over time. The database now provides information on more than 1,250 case studies that have been published since 2017, and more are added regularly as

additional journal editions are released. The goal of the project is to provide a long-term, sustainable repository of cases for individuals to use any time they hope to utilize such materials in their teaching initiatives. Beyond this ongoing work on the database, two additional initiatives have been developed. The first will explore non-academic case studies for inclusion in the searchable format, from FEMA, HUD, EPA, and other organizations/agencies. These case studies will allow for more direct search criteria for those hoping to find information outside of academic journals. The second additional project will establish a special collections component of the DEM Teaching Cases Repository that focuses on the distinct areas of COVID-19 and Vulnerable/Underserved Populations respectively.

Given the ongoing impact of COVID-19, and growing research on vulnerability and resilience, these collections curate existing cases, identify promising sources for cases and case development, as well as identify knowledge gap areas where cases should be developed that would advance the academic knowledge and professional practice in each collection. Currently, data collection for case studies and key scholarly journal articles are ongoing under the supervision of Case Teaching and Learning Special Interest Group Lead, Dr. Jane Kushma. Data is currently stored in a protected folder under the title "DEM Teaching Cases Repository" with two sub-folders entitled "COVID-19" and "Vulnerable Population." Review of the articles will focus on specific inclusion/exclusion in addition to the criteria listed above to ensure the best research is identified for potential teaching cases. As the special collections process is slated to be completed in May 2021, data collection and analysis will culminate in a full report of findings within the next year. Additionally, with each special collection, analysis of trends has become an area of interest to help identify areas of improvement and spotlight notable changes in approaches based on the COVID-19 timelines of response and recovery from identified articles and cases. The addition of each collection to the case repository will allow academics, researchers, and practitioners to identify additional opportunities for teaching and learning.

Special Interest Groups

Special Interest Groups (SIGs) are self-organized and self-directed by members of the community for knowledge exchange on specific topics related to emergency management higher education. FEMA Releases 2020 National Preparedness Report

FEMA released the 2020 National Preparedness Report (https://www.fema.gov/emergency-managers/national-preparedness#reports), which addresses data available as of December 31, 2019. In its ninth year, this report presents an updated, risk-focused summary of the state of national preparedness. The 2020 report presents a discussion of the risks the Nation faces and how those risks drive the Nation's capability requirements, as well as how the Nation uses capabilities to manage risks, including a high-level overview of the Nation's current capabilities. The 2020 report found that although affected communities may not be fully prepared to respond to nationally catastrophic incidents, an analysis of shared national capabilities indicates the Nation as a whole is closer to achieving its national goals though some significant capability gaps still remain. The report also highlights some of the persistent challenges the Nation faces, how the Nation is working collectively to solve those challenges, and what the Nation must continue to do to build on those successes. It also provides a deeper assessment of four identified focus areas: Cascading Impacts, Public-Private Partnerships, Vulnerable Populations, and Housing.

As an annual requirement of Presidential Policy Directive 8 and consistent with the Post-Katrina Emergency Management Reform Act reporting responsibilities, the National Preparedness Report has assessed the Nation's preparedness posture since 2012. This report provides partners across the Nation with insights into risks, vulnerabilities, and capabilities to support decisions about program priorities, resource allocations, and community actions. The National Preparedness Report published in 2021 will explore the impacts of the coronavirus (COVID-19) pandemic and evaluate the response, using data that becomes available as the incident continues.
