#### EFFECTIVE IMMEDIATELY:

All employees, contractors, students, and other individuals working on behalf of EMI must comply with copyright legislation and regulations.

Any use of third-party content in instructional materials must be accompanied by express written permission or license from the copyright-holder or approval for use from FEMA Office of Chief Counsel (OCC). Third-party content includes works created by someone other than yourself; written, visual, and audio media; and copyrighted or trademarked formats, for example, well-known gameshows.

Necessary permissions/licenses from the authors/owners or approvals from FEMA OCC must be obtained during the development of a project and prior to its completion.

### **COMPLIANCE REQUIREMENTS:**

For each project, EMI copyright records shall include a signed EMI Copyright Compliance Letter providing:

- 1. A signed statement indicating that no third-party content is incorporated into the project; or
- 2. If third-party content is incorporated into the project:
  - a. Express written permission from the author/owner for use of the third-party content, e.g, a license, or
  - b. An express written approval from FEMA OCC that the third-party content is available for use, e.g., is in the public domain, is a fair use, etc.

A Copyright Compliance Letter is attached hereto as Attachment A.
