Course: E0390 Integrating Emergency Management Education into Your Institution

Course Dates: February 25-26, 2018

Travel Dates: February 24 and February 27, 2018

Course Length: This course is 2 days in length.

Location:

Emergency Management Institute (EMI) National Emergency Training Center (NETC) Emmitsburg, Maryland

Course Description:

This course is an interactive workshop designed to assist **minority and minority-serving institutions of higher education (IHEs)** in establishing or enhancing Emergency Management (EM) courses or programs in their institutions. It addresses issues unique to them, and begins the process of identifying and overcoming institutional roadblocks to increasing their schools' EM-related offerings.

Course Goal:

The primary goal of this workshop is to assist Hispanic Serving Institutions, Asian American and Pacific Islanders, Tribal Colleges and Universities, and Historically Black Colleges and Universities by providing information about EM and the benefits and resources available for integrating EM course offerings. The desired outcome and single focus of the course is to achieve a more diverse population of EM professionals who reflect the communities in which they live and work.

Prerequisites: None

Continuing Education Units (CEU's): EMI awards 1.4 CEUs for completion of this course.

Target Audience:

Hispanic-Serving Institutions (HSIs) and Asian American and Pacific Islander Institutions (AAPIs). This is the first of three offerings in FY 2019. The audience for the February class includes Department Chairs and faculty of EMrelated or EM-impacted disciplines such as sociology, geography, public administration, psychology of science and technology from HSIs and AAPIs.

Enrollment is limited to 15 participants for this offering, enrolled on a first-come, first-served basis. Transportation expenses for attendees will be reimbursed through EMI's student stipend program. Airport shuttles are available and lodging is provided for course participants on the NETC campus.

To Apply:

Complete a FEMA Form 119-25-1, General Admissions Application, with student signature and signature of supervisor or sponsoring agency official. Submit the application through the State Emergency Management Training Office. FEMA

Individuals applying for EMI classes will be required to register using the FEMA Student Identification (SID) number. This number will be used in place of the Social Security Number (SSN) on your application form. <u>The SSN is no</u> <u>Ionger required</u>.

How do I obtain my FEMA SID number?

- Step 3. Follow the instructions and provide the necessary information to create your account.
- Step 4. You will receive an email with your SID number. You should save this number in a secure location.

NATIONAL EMERGENCY TRAINING CENTER (NETC) CAMPUS ACCESS – REAL ID ACT STANDARDS

Does your ID meet the Real ID Act standards? Anyone entering the National Emergency Training Center (NETC) campus is required to show valid photo identification that meets <u>REAL ID Act</u> <u>standards</u>. The purpose of the REAL ID Act is to stop terrorists from evading detection by using false identification. Check to <u>see if your state is</u> <u>compliant</u> at <u>https://www.dhs.gov/current-statusstates-territories</u>.

If your driver's license does not meet the requirements of the REAL ID Act, you will need to bring one of the following acceptable forms of identification:

• A valid U.S. passport or passport card.

- A valid federal employee, military, or veteran ID • card.
- A valid state-enhanced driver's license (Contact your state's motor vehicle department for availability).

Students from non-compliant states (a regular driver's license from these states will not be accepted) who do not possess any acceptable form of identification may request a National Crime Information Center (NCIC) check from the NETC Security Office. Note: This is a one-time NCIC check; a successful NCIC check is valid for 180 days; within the 180 day time-frame a student is expected to obtain a compliant form of identification).

Submit the following information to Jason.Cawthon@fema.dhs.gov in a passwordprotected document at least three weeks before your class:

- Your full name •
- Date and place of birth
- Social Security Number

Students arriving at the NETC campus without a compliant ID or a successful NCIC criminal history check will be sent home at their own expense without receiving a stipend reimbursement.
