**Selection Criteria:**

NIMS ICS All-Hazards training should be completed by personnel who are regularly assigned to Functional, Support, or Unit Leader positions on Type 3 or 4 AHIMTs, or by those persons who desire to seek credentials/certification in those positions.

Applicants for admission into All-Hazards Position-Specific (AHPS) Train-the-Trainer (TtT) program must:

- Have completed the course they desire to teach prior to applying for acceptance into the TtT program.
- Be fully qualified in the position they are applying to teach; completed Position Task Book (PTB).
- Have documented experience serving in the position on Type 3, Type 2, or Type 1 AHIMT(S).
- Possess the necessary instructor fundamentals training and desire needed to teach the course.

### **Training Prerequisites:**

Most current versions of IS-100, 200, 700 & 800, and ICS 300. For section chief and TtT course applications, you must have completed ICS 400 and the basic course for the TtT which you are applying.

### **Experience Prerequisites:**

The applicant must have a solid background in ICS, experience and related credentials as an instructor. In addition, all applicants for any AHPS TtT must be qualified as a Type III credential holder **and** have active participation in the position on an IMT over the past 5 years.

### **To Apply:**

All applicants must complete a FEMA Form 119-25-1, General Admissions Application, with student signature and signature of supervisor or sponsoring agency official. Submit the application through the State Emergency Management Training Office. Ensure all applicable certificates of training, copies of credentials as a Type III IMT member, or documentation of a minimum of active participation in the position on an IMT over the past 5 years.

FEMA Regional employees should submit their application to their Regional Training Manager (RTM).

Tribal representatives can submit their application directly to NETC Admission Office.

Tribal government representatives, private industry, and Federal government employees DO NOT need to submit applications through the State Emergency Management Training office or FEMA Regional Office. Mail, scan, and e-mail, or fax the signed application to:

### **Application Review:**

Refer to the Target Audience statement **and indicate how you meet the requirements based upon your position and experience**. Ensure all applicable certificates of training, copies of credentials as a Type III IMT member, or documentation of a minimum of active participation in the position on an IMT over the past 5 years, are attached.

#### **Travel Authorizations:**

PFT and CORE employees must ensure their travel authorization (TA) is completed through Concur Government Edition (CGE) Travel System for course offerings. All Federal travelers must have an approved TA prior to travel.

#### **Notice to Applicants for EMI courses:**

Individuals applying for EMI classes will be required to register using the FEMA Student Identification (SID) number. This number will be used in place of the Social Security Number (SSN) on your application form.

**The SSN is no longer required.**

#### **How do I obtain my FEMA SID number?**

1. To register, [click here to go to the FEMA Student Identification System website](#).
2. Click on the "Register for a FEMA SID" button on screen.
3. Follow the instructions and provide the necessary information to create your account.
4. You will receive an email with your SID number. You should save this number in a secure location.

#### **NATIONAL EMERGENCY TRAINING CENTER (NETC) CAMPUS ACCESS – REAL ID ACT STANDARDS:**

Does your ID meet the Real ID Act standards? Anyone entering the National Emergency Training Center (NETC) campus is required to show valid photo identification that meets REAL ID Act Standards. The purpose of the REAL ID Act is to stop terrorists from evading detection by using false identification. [Click and check here to see if your state is compliant](#).

If your driver's license does not meet the requirements of the REAL ID Act, you will need to bring one of the following acceptable forms of identification:

- A valid U.S. passport or passport card.
- A valid federal employee, military, or veteran ID card.
- A valid state-enhanced driver's license (Contact your state's motor vehicle department for availability).

Students from non-compliant states (a regular driver's license from these states will not be accepted) who do not possess any acceptable form of identification may request a National Crime Information Center (NCIC) check from the NETC Security Office. Note: This is a one-time NCIC check; a successful NCIC check is valid for 180 days; within the 180 day timeframe a student is expected to obtain a compliant form of identification).

- Date and place of birth

- Social Security Number

Students arriving at the NETC campus without a compliant ID or a successful NCIC criminal history check will be sent home at their own expense without receiving a stipend reimbursement.
