Course: E/K/L0146 – Homeland Security Exercise Evaluation Program (HSEEP) - Fiscal Year 2020

E/K/L0146 HSEEP is a basic level course that provides a comprehensive overview of exercise program management, design, development, conduct, evaluation, and improvement planning along with practical skill development using HSEEP doctrine. The course is composed of structured activities that allow participants to interact with templates provided by the National Exercise Division. Upon completion, participants will gain a better understanding of how to utilize an HSEEP exercise.

The E0146 is delivered by the Emergency Management Institute (EMI) and is a component of the Emergency Management Professional Program, Basic Academy.

The K0146 is delivered via a webinar format that includes: classroom-like lecture, work group activities (which reinforce the concepts taught during lecture), a pretest knowledge check, and a posttest to assess participants' knowledge gain. K0146 courses are conducted online via Adobe Connect, in 4-hour blocks over four consecutive days, Monday through Thursday. Of note, all courses will be scheduled from 1:00-5:00 PM (EST).

The L0146 is delivered in a traditional classroom environment, at a local jurisdiction, and incorporates all the same elements as the webinar version. L0146 courses are 16 hours in duration and can be delivered over two or three days.

Participant must complete all 16 hours of this course and pass the posttest to receive full credit; anything less will result in the need to reregister for another course.

Topics to be covered include:

- Unit 1: Introduction and HSEEP Fundamentals
- Unit 2: HSEEP Program Management
- Unit 3: Exercise Design and Development
- Unit 4: Exercise Conduct
- Unit 5: Exercise Evaluation
- Unit 6: Exercise Improvement Planning

Participants are required to have completed IS-0120 – *An Introduction to Exercises*. It is also recommended that participants take IS-0130 - *Exercise Evaluation and Improvement Planning*.

K0146 HSEEP course: Complete a FEMA Form 119-25-1, "General Admissions Application Form" with student signature and signature of supervisor or sponsoring agency official, then submit the application through your State Training Office. Email application and the IS-120 (a or c) "An Introduction to Exercises" certificate six weeks prior to course date, to email: netcadmissions@fema.dhs.gov. K0146 HSEEP course will be added to the online registration system in the future. Upon acceptance into the course, NETC admissions will email the student.

E/L0146 HSEEP course: The National Emergency Training Center is implementing an <u>Online Admissions</u> <u>Application</u> process for the E/L0146 HSEEP course (link can also be accessed at the following URL address: https://training.fema.gov/onlineadmissions).
