- Demonstrate effective teaching techniques including setting the environment, maximizing learning retention, conveying information, and assessing student progress.
- Model appropriate behavior as an instructor.

#### Course Length:

- Total time: 24 hours over 2 weeks, and 4 hours of self-study
- Class Time: 24 hours (EST)
- Self-study estimated time (4 hours)
