Save the Date: National Qualification System (NQS) Informational Webinars

The FEMA National Integration Center and the Emergency Management Institute NIMS Training staff will be presenting a series of 1-hour NQS informational webinars for state, territorial, tribal, and local (SLTT) Training Officers, NIMS coordinators and NQS implementers in April 2023. The purpose of these webinars is to discuss NQS implementation best practices and to address questions and concerns from SLTT partners related to Phase 1 of the NQS Implementation Objectives. The desired outcome is for SLTT partners to gain a better understanding of NQS implementation. The format for the webinar will be primarily focused on discussions of implementation questions submitted by participants. The webinars will be conducted by region with times aligned to make them more accessible to other time zones. The tentative schedule is:

- Regions 1-4 mid-morning (EST) on Monday, 10 April
- Regions 5-7 mid-afternoon (EST) on Tuesday 11 April
- Regions 8-10 late afternoon (EST) on Thursday 13 April

EMI to Launch a New Learning Management System (LMS)

Exciting news! EMI is enhancing our learning experience with a new learning management system set to launch this Spring! The new system promises a more interactive and convenient experience, allowing for progress tracking and access to a host of student services, all in one place. As part of the rollout, all current and former students will need to go through a new logon and verification process the first time they visit the site. It is essential to ensure that your FEMA Student ID (SID) information is accurate and up to date.

To prepare for the launch, take these steps:

1. Verify and update your FEMA SID information by clicking on "Edit Profile" in the <u>FEMA Student ID System</u> (*https://cdp.dhs.gov/femasid*). Self-help actions and FAQs are available to guide you through this process.

- 2. Review a copy of your Student Transcript (Independent Study only) from the <u>EMI Student Portal</u> (*https://training.fema.gov/student/sssp.aspx*). Please ensure your SID information is up to date before completing this step.
- 3. Review your transcript for accuracy and make any necessary corrections before the new system goes live.

News from the EMI Branches

Preparedness:

EMI Preparedness Branch will be reinstituting the EMI e-Forum every other Wednesday, 1500 to 1600 beginning 29 March 2023. The format is built around a short program agenda, with a question/answer period and moving to open discussion. We will focus on two primary groups – state, tribal, and territorial training officers (hereafter called STOs) and the NIMS Core and Position-Specific Instructors.

The 29 March e-Forum is for the STOs. This forum will focus on current issues and challenges for scheduling NIMS Core and Position Specific training. The following e-Forum on 12 April will be targeting the NIMS ICS Core and Position-Specific instructors and the same format will be used.

We will send out a broadcast with the webinar links and other information over the next few days via social media, direct email to the STOs and other training partners.

ICS 300 and ICS 400 FEMA and SLTT student registration process:

- For L300 and L400 deliveries that will have 100% FEMA students, the Deployment Tracking System (DTS) will continue to be the system of record for registering.
- For L300 and L400 deliveries that will include SLTT students, ALL students must register through the NETC Online Admission system using an invitation/enrollment code.
 - Students will receive the standard EMI course completion certificate, once NETC Admissions receives the course close-out package.
 - FEMA students will need to have their DTS records updated to reflect this completion. To have DTS records updated, students will need to submit a request for credit to the FEMA Incident Workforce Academy (FIWA) Training Team at <u>fema-fqs-training@fema.dhs.gov</u>.

Hazard Mitigation Assistance (HMA):

Seats are still available for the next offering of the E0212 Hazard Mitigation Assistance: Developing Quality Application Elements course. This class is convening April 24-27, 2023, on the EMI campus in Emmitsburg, MD. The purpose of this course is to educate students in the process of developing quality mitigation planning and project grant application elements for the Unified Hazard Mitigation Assistance (HMA) grant programs. It is intended for local jurisdictions, tribal governments, non-profit organizations, state, FEMA employees, and public or private sector organizations that offer consulting services to Unified HMA grant applicants.

A virtual 5-day offering of this course, K0212 Hazard Mitigation Assistance: Developing Quality Application Elements, will be offered this summer from June 6-9, 2023. There are currently 45 seats open for this course. All applications must be submitted via the NETC Online Admissions system. FEMA personnel requiring this course for their Position Task Book (PTB) must contact the FQS training team directly.

Integrated Emergency Management (IEM):

Virtual Tabletop Exercises (VTTX): EMI conducts a series of VTTX using a virtual platform to reach community-based training audiences around the country and provide a virtual forum for disaster training. The VTTX process involves key personnel from the emergency management Community of Practice (CoP) reviewing a pre-packaged set of exercise materials and convening for a four-hour tabletop exercise discussion of a simulated disaster scenario with a total of 10-15 other CoP groups participating. This VTTX is designed to engage the participants in a no fault, hazard-specific exercise discussion. Facilitation will occur online from EMI and will need to be complimented by a dedicated local agency facilitator at each participating site. The participating location must provide a person capable of facilitating the onsite portion of this discussion-based exercise. Note: The VTTX runs each day of the offering from 12:00 PM-4:00 PM Eastern Time. You only need to choose **ONE** date of the offering; however, please provide an alternate date as well.
