Good Day Hi Ed Community! This week, I was in the National Emergency Management [Executive Academy](#) Course, [Integrating Science into Emergency Management Policies and Decisions](#) held at EMI, and I have been thinking more deeply about the relationship between scientists, emergency management practitioners and academics. I am contemplating the opportunities for us to work more closely and cultivate greater understanding to integrate science and technology into emergency management higher education curricula, design and delivery.

Since our last [newsletter](#), a colleague reached out to me to discuss [initiatives](#) of the White House Office of Science and Technology Policy to focus on integrating a science and technology capabilities into the emergency management. As an educator she immediately saw the connection between this need and how we might address this through emergency management curricula. The [Federal Communications Commission](#) is seeking comments on the potential sharing of the 1675-1680 MHz spectrum band used by the [National Oceanic and Atmospheric Administration](#) (NOAA) for weather satellite direct broadcast of real-time information crucial to weather and flood warnings. Individuals and organizations that currently utilize direct readout data from NOAA satellites, and all who rely on [National Weather Service](#) weather and flood warnings, may [submit comments by June 21, 2016](#).
