This week started out with most of the workforce at FEMA's National Emergency Training Center and Emergency Management Institute (EMI) repositioning to provide surge training for Hurricane Matthew. Fortunately, the surge training was not necessary but many people have traveled to locations near the disaster sites deployed to support response operations. In addition, there is a call center located here at EMI. Our own Barbara Johnson is working to staff the call center, providing critical information and a compassionate ear to Hurricane Matthew disaster survivors.

This Friday, I will head to Savannah, Georgia for the International Association of Emergency Managers (IAEM) Annual Conference. There, I will be supporting the EMI pre-conference trainings, staffing the EMI exhibit booth, serving on a panel co-hosted by the IAEM Global Student Council and the International Network of Women in Emergency Management on the topic of Strategic Mentoring in the 21st Century, supporting the Emergency Management Professional Program panel as well as networking with many old and soon to be new friends.
