Higher Education Updates

Message from Wendy Walsh, Higher Education Program Manager

It was a great week in Savannah, Georgia at the International Association of Emergency Managers (IAEM) Conference. I reconnected with many of our Higher Education community members, met several new people, had great conversations and learned a lot! The week started off with the delivery of EMI courses to IAEM membership. It is always inspiring to sit in the back of the class and learn about how different jurisdictions manage building resilience, address recovery and improve overall situational awareness.

FEMA leadership attended the conference. There was a FEMA leadership panel that was very well attended, and FEMA Administrator Craig Fugate provided a very inspiring keynote lunch!

There were outstanding presentations delivered by academics, practitioners and other stakeholders. Highlights included a fantastic discussion on the identity of emergency management facilitated by Jessica Jensen from North Dakota State University as well as an informative session on the gap between the emergency manager student and practitioner experience delivered by Brent Cox from Arkansas State University. Faculty brought several students to volunteer and participate, and Carol Hackerott from Arkansas Tech University brought an outstanding representation of 13 students to the conference. Valerie Lucus-McEwen from California State Long Beach University supported the USA Student Group and the emergency management student honors association, Epsilon Pi Phi, with Dorothy Miller, Epsilon Pi Phi Executive Director and Emergency Management Coordinator for the City Of Round Rock Texas.

I had an opportunity to speak on a panel hosted by the IAEM Global Student Group and the International Network of Women in Emergency Management (inWEM). This panel was for emergency management students to discuss the opportunities and roles of emergency management at different levels of government and also encompassed other potential career paths in emergency management.

FEMA Emergency Management Institute (EMI) Deputy Superintendent, Paul Butki, moderated a panel to discuss the Emergency Management Professional Program (EMPP). Five graduates and instructors from the Basic, Advanced and Executive Academies participated, and it was very well received. EMI's National Training Liaison, Dan Lubman, and I staffed the EMI information booth in the Expo area. We shared a lot of information regarding training, instructor recruiting, the EMPP and the Emergency Management Higher Education Program. There were hundreds of visitors to our booth.





The EMI team attended the IAEM Training & Education Committee Meeting to provide an update led by our own Superintendent Tony Russell.
