### Higher Education Updates

#### Message from Wendy Walsh, Higher Education Program Manager

This week Ms. Lillian Virgil, EMI Mitigation Branch Chief, and I attended the National Historically Black Colleges and Universities (HBCU) Week Conference in Washington D.C. It was a very informative and inspiring few days. We met a lot of new people, learned about the great strides made by the HBCU academic community and was very impressed by the passion, intellect and professionalism of the HBCU All-Star Students. We had the opportunity to meet with several Higher Education community members who are working in HBCUs. We also shared the upcoming EMI E0390 course, [Integrating Emergency Management Education into Your Institution Course](#), which is designed for minority and minority-serving institutions of higher education.

The purpose of the conference was to address the priorities conveyed in [Presidential Executive Order 13532](#). There were many celebrations of the accomplishments of HBCU institutions in the science, technology, engineering, and math (STEM) fields as well as advancing the cause of equality and opportunity for all people. The main challenges expressed were student completion and program sustainment. To address these areas several breakout sessions were held to promote: federal government engagement, collaborative research, STEM investments, innovation, fundraising, effective board governance, leadership in driving diversity, recruitment, internships and how to leverage federal contracting opportunities.

HBCU institutions have a rich story of triumph in the face of incredible obstacles! Several times I heard speakers mention the metaphor that they are standing on the shoulders of giants. While the challenges faced today are tough, 'due to the great advances in civil rights and community achievements, HBCU are emerging as leaders in STEM fields, providing higher educational opportunities to students who would have otherwise not been able to participate and producing notable PhDs.

Many attendees took the time to visit the new [National Museum of African American History & Culture](#) while they were in town and highly recommend this powerful and educational experience. There are a lot of resources on the museum webpage that would be interesting and powerful additions to curriculum. For example the great Mississippi River Flood of 1927 story can be found [here](#). This story covers the impact, providing pictures, maps and songs that capture the impact to the African American population. During this flood, "Hundreds of thousands of African Americans were displaced from their communities and workplaces."
