How to Become an NDEMU Contract Instructor



General Requirements

Course-Specific Requirements

NDEMU instructors must have subject-area expertise and proven successful teaching experience for the courses they teach. Course-specific requirements for applicant instructors may be found on our website under the EMI Biddable Course List at https:// training.fema.gov/instructors/ biddable.aspx.

Education

Education requirements are specified for each course. All degree requirements must be from an institution that is accredited by Institutions of Higher Education.

Instruction Experience

All potential instructors shall have completed formal instructor training such as:

- The NDEMU Instructional Presentation and Evaluation Skills (E0141) course.
- The Center for Domestic Preparedness (CDP) Instructor Training Certification (ITC) course, PER-266.
- EMI Conduct and Behavior (IS-0013).
- Programs offered by a state or Federal agency.

How to Submit an Application

Electronic Application Process

Submit a cover letter that lists up to five (5) courses you would like to instruct and a resume outlining your experience. Include:

- Documentation necessary to demonstrate that you meet the course-specific requirements;
- A link to a 30-minute teaching demonstration; and
- · At least two references.

Administrative Requirements

Once you have been notified that you meet the selection standards, you will be required to complete the following administrative requirements:

- Submit to National Crime Information Center (NCIC) check.
- Obtain a <u>Unique Entity Identifier</u> (UEI). You should contact the entity designated at www.sam.gov directly to obtain your UEI.
- Register your UEI in the <u>System for</u>
 <u>Award Management</u> at
 www.sam.gov.
