EMI Delivers Courses During the International Association of Emergency Managers (IAEM) 2023 Conference

EMI delivered courses during the IAEM Conference in Long Beach, California. Students from across the nation and around the world attended this training prior to the conference. The EMI Preparedness Branch delivered two National Incident Management (NIMS) courses to the conference attendees: L0975 Finance/Administration Unit Leader saw 23 students complete the course, and the L0191 Emergency Operations Center (EOC)/Incident Command System (ICS) Interface courses saw 40 students complete the course. Additionally, EMI's Emergency Management Professionals Program delivered a L0102 Science for Disasters, with 35 students completing the course.

Preparedness:

South Carolina Mid-Year Incident Management Academy; Partnership – Innovation – Collaboration; A New Blueprint for Success: Friday, November 3, 2023, Columbia, South Carolina (SC) - A pioneering initiative has successfully concluded with the completion of six National Incident Management (NIMS) courses in the Incident Command System (ICS) Position Specific (PS) curriculum at the SC Fire Academy. This milestone achievement was made possible through the collaborative efforts of FEMA's Emergency Management Institute (EMI), SC Fire, SC Emergency Management, the Palmetto Incident Support Team, and the Incident Management Teams Association.

One standout feature of this inaugural academy was the introduction of seven satellite classrooms spanning three time zones. These classrooms were seamlessly integrated into the main hub in SC, where the lead instructor delivered the LO956 Liaison Officer (LOFR) course in a groundbreaking hybrid format. Support instructors stationed at each satellite site conducted course units and oversaw interactive activities. During group activities, students from different locations were able to work together, enriching the learning process with their diverse perspectives. To cap off the course, participants completed their final assessments using EMI's independent study testing system.

Students and instructors from 8 locations; Renton, WA, Taylorsville, UT, Valparaiso, IN, Altoona, WI, Baton Rouge, LA, North Chesterfield, VA, Raleigh, NC, and the central hub in

Columbia, SC, were all integral parts of this endeavor.

Utilizing standard web-based conference technology, the sessions were broadcast to all sites, with most locations also benefiting from the support of a dedicated producer, who was often an additional instructor or a State Training Officer.

Meanwhile, the SC Fire Academy welcomed students from ten other states; Texas, Missouri, Georgia, Illinois, Indiana, New York, North Carolina, Tennessee, Virginia, and Wisconsin, all of whom traveled to attend the six in-person courses.

This unprecedented event will see 152 students receiving certificates from the six courses in just one week, with 101 of these

certificates coming from the L0956 LOFR - Hybrid course alone.

The Fiscal Year (FY) 2025 Community-Specific Integrated Emergency Management Course (IEMC) Training Bulletin is out for distribution: We are excited to announce that the application process for the Fiscal Year (FY) 2025 Community-Specific Integrated Emergency Management Course (IEMC) offered by FEMA's Emergency Management Institute (EMI) is now open! This is a phenomenal opportunity to enhance the emergency preparedness and response capabilities of your jurisdiction.

Program Overview: The IEMC provides a unique, activity-based training environment for Emergency Operations Center (EOC) personnel, immersing them in realistic crisis scenarios to build awareness and sharpen skills. Jurisdictions have the freedom to select specific hazards and Core Capabilities to be incorporated into the training, ensuring relevance and applicability to local needs.

Application Deadline: ensure all applications are submitted to your respective FEMA Region by December 11, 2023.

Cohort 24-1 has eagerly embarked on the E0237 Planning Process Theory and Application Course, a critical component of the PPP series designed to enhance the skills and knowledge of operational planning professionals. As the risk landscape continues to evolve in complexity, the importance of deliberate and strategic planning has never been more paramount. The PPP aims to

equip planners with the necessary tools and understanding to navigate these challenges, mitigate potential losses, and improve outcomes in the face of various hazards, threats, and risks.

The E0237 course serves as a foundation for planners, offering a comprehensive curriculum that covers essential topics such as Planning Theory and Application, Project Management in the Planning Process, and Complex Adaptive Systems in Emergency Management. Participants will engage in rigorous training, learning to effectively apply the six-step planning process and enhance stakeholder selection and engagement. The program is meticulously designed to ensure that the knowledge

acquired is not just theoretical but also applicable, allowing planners to directly implement these concepts within their respective jurisdictions. This approach ensures a seamless integration of learning and practice, strengthening the vertical integration of emergency management planning at all governmental levels.

The Planning Practitioner Program is tailored for experienced individuals who play significant roles in operational planning programs, with Cohort 24-1 comprising appointed emergency management staff, public safety personnel, and various other professionals with substantial planning responsibilities. These participants bring a wealth of experience, having been deeply involved in emergency management planning activities for at least five years. As they navigate through the E0237 course, they are not just gaining knowledge but also contributing their unique insights and experiences, enriching the learning environment for all. The kickoff of this year's program is more than just the start of a course; it is the continuation of a commitment to excellence in emergency management planning, ensuring that our communities are safer, more resilient, and better prepared for the future.

Mitigation:

Floodplain Management: Seats remain available for E0273 Managing Floodplain Development through the National Flood Insurance Program (NFIP) scheduled February 12-15, 2024, March 11-14, 2024, April 22-25, 2024, and September 9-12, 2024, on the EMI campus. This course provides local, state, tribal, territorial, and Federal officials with the knowledge and skills to administer and enforce floodplain management regulations. The course focuses on the NFIP and concepts of floodplain management, flood maps and studies, ordinance administration, and the relationship between floodplain management and flood insurance.

Seats also remain available for E0278 National Flood Insurance Program/Community Rating System (NFIP/CRS) scheduled February 26-29, 2024. This will be the only FY24 offering on the EMI campus. This course covers the Community Rating System (CRS), a nationwide initiative of FEMA's National Flood Insurance Program (NFIP). It describes activities eligible for credit under the 2017 CRS Coordinator's Manual, how a community applies, and how a community modifies an application to improve its classification.

Applications for both the E0273 and E0278 offerings will be processed thru the NETC Online Application system.

Building Science: To provide the most up-to-date and relevant training, Building Science is temporarily placing the courses listed below in "under revision not available for request" to develop more current content. This temporary suspension is a critical step in our continuous improvement approach to provide high-quality training. This proactive step allows us to create cutting-edge content aligned with the current demands of the community. Flood Insurance: All the Flood Insurance Independent Study courses on the EMI IS website are in the process of being reviewed to either be updated or retired if determined to be no longer relevant. While waiting for the posting of current content, several options for training are available. Below are links to FEMA's official training websites where you can register for an upcoming webinar. Hazard Mitigation Assistance (HMA): The HMA Program Office suite of courses (0212 Developing Quality Sub-Application Elements, 0213 Hazard Mitigation Assistance: Application Review and Evaluation and 0214 Hazard Mitigation Assistance: Project Implementation and Programmatic Closeout) are being revised to incorporate interactive activities that will enhance the comprehension of the concepts taught in the courses through a series of hands-on practical applications with real world, current case studies. Pilot offerings of 0212 (one resident and two L course deliveries) were completed earlier this year. The pilot offerings of 0213 and 0214 were completed September 18 – 21 at EMI. During the pilot offerings, the Program Office, EMI, and the instructors identified the need for significant modifications in order to enhance the delivery of this course and had great discussions with the students on how to provide better training on these topics.

Given the feedback that was received from all the pilot offerings, significant revisions need to be made to the entire suite of courses, which moves the estimated timeline for delivery of all three courses to the January/February 2024 timeframe.

Updates to the availability of the courses will continue to be communicated in both the EMI Newsletter and Program Office communications.

Please note that L course requests cannot be approved until the course updates are finalized and ready for delivery. We highly advise all communities to refrain from submitting L course requests for L0212, L0213, and L0214 until further notice.

Ask a Course Manager

Does the Emergency Management Institute (EMI) mandate the completion of the NSEC Advanced-level exercise courses (E/L/K-0139, E/L-0050, E/L/K-0131, and K-0051) as a prerequisite for the Master Exercise Practitioner Program (MEPP)?

No, not currently. The prevailing prerequisites for enrollment in the MEPP Program are as follows: L/K-0146 (HSEEP program), IS-100, IS-120, IS-130, IS-200, IS-230, IS-235, IS-700, IS-800, and IS-2200. As the newly established NSEC Advanced-level courses become more accessible to the wider community, they are expected to be incorporated as mandatory prerequisites for MEPP in the coming years. Any such requirement will be officially communicated through updates on the MEPP website and distributed through various annual announcements channels.
