## FEMA National Exercise Program Now Accepting Requests for Exercise Support

FEMA's National Exercise Program is accepting requests for exercise support. To be considered for the 2023 round of the National Exercise Program, submissions are due by June 1. This will be the only opportunity to request exercise support in 2023. For jurisdictions not ready to submit a request at this time, the National Exercise Program will hold another exercise support round in 2024.

Applications are open to all state, local, tribal, and territorial governments but new applicants, especially those from underserved jurisdictions, are urged to apply.

The National Exercise Program is a cycle of exercises across the nation that examine and validate capabilities in all preparedness mission areas. The National Exercise Program offers state, local, tribal, and territorial jurisdictions no-cost assistance for exercise design, development, conduct, and evaluation to validate capabilities across all mission areas.

**National Qualification System (NQS) Informational Webinars:** The FEMA National Integration Center and the FEMA Emergency Management Institute NIMS Training staff will be presenting a series of 1-hour NQS informational webinars for State, Territorial, Tribal and local (SLTT) Training Officers, NIMS coordinators and NQS implementers on April 10th, 11th and 13th, 2023. The purpose of the webinars is to discuss NQS implementation best practices, and address questions from SLTT partners related to Phase 1 of the NQS Implementation Objectives. ## Mission Support:

**Reaching Across Oceans - Community Emergency Response Teams (CERT Training):** When this winter brought snow and a nor'easter to the Northeast, flooding, snow, and tornadoes to the middle of the United States, and powerful rain and snow, including multiple atmospheric river events, to the West Coast, members of CERT supported responders by filling sandbags, helping to staff cold weather shelters, and deploying to assist with a range of activities, e.g., food and fuel deliveries.

To learn how to bring CERTs to other parts of the world, the Peace Corps turned to the Emergency Management Institute (EMI) to deliver the CERT Train-the-Trainer course to volunteers preparing to start CERT programs and teach the CERT Basic course in their countries.

Peace Corps volunteers from Guyana, Paraguay, the Philippines, Tonga, Vanuatu (South Pacific Ocean nation), and the Eastern Caribbean (Dominica, Saint Lucia, Grenada, St. Vincent, and the Grenadines), who completed the CERT Train-the-Trainer course in March, face disasters and their effects much as their counterparts do in the United States.

While the United States has been challenged by weather events this winter, Peace Corps volunteers contended with a history-making tropical cyclone, said to be the longest-lasting storm of its kind. Tropical Cyclone Freddy killed at least 21 people across Mozambique and Madagascar, affecting nearly 2 million people.

Soon after the March class began, two Category Four cyclones tore through Vanuatu's communities during a week that also included a magnitude 6.6 earthquake just off the island of Espiritu Santo. One of the CERT students, a volunteer in Vanuatu, described the initial disaster conditions and response (while there was still power).

Before delivering the training, EMI CERT instructors surveyed the students to determine the environmental shocks and stressors that most need to be addressed in their countries. Depending on their locations, what do they face?

- Tropical Cyclones, storms, troughs, and hurricanes
- Coastal Storm Surges
- Droughts: lack of water for crop production; prolonged droughts that increase wildfires
- Heatwaves
- Floods
- Heavy Rains
- Thunderstorms/Lightning
- Landslides
- Saharan Dust
- Earthquakes
- Tsunamis
- Volcanic Activity
- Vector-borne illnesses: specifically, dengue, chikungunya, and zika (mosquito-borne viruses) with increased rain and poor solid waste management throughout the country
- Cholera outbreaks due to lack of clean water

While students found the CERT Basic training materials to be very helpful, they discussed the challenges of creating a supply chain management system in their countries during emergencies, acquiring the supplies needed to teach the CERT Basic course, and getting buy-in from local governments.

As thousands of citizens around the globe suffer deaths, injuries, and billions of dollars of economic losses from natural disasters, the contributions and support from Community Emergency Response Teams worldwide have never been more important.

## **Integrated Emergency Management (IEM):**

**Osceola County, Florida's Community Specific Integrated Emergency Management Course (IEMC) E0930.** The Integrated Emergency Management (IEM) Branch hosted Osceola County, FL for an IEMC focused on activating the County Emergency Operations Center (EOC) for Tornado Activity. The four-day course included classroom learning and three exercises focused on response and recovery.

Bill Litton, Director, Osceola County Office of Emergency Management said, "*Osceola County had the opportunity to participate in Integrated Emergency Management Course – Community Specific in March 2023. This course allowed us to bring 55 individuals from Osceola County, City of Kissimmee, City of St. Cloud, and various external partners to*



*include the National Weather Service – Melbourne, University of Central Florida (UCF) – Victim Services and FL District 9 Medical Examiner’s Office to test the EOC response to a tornado outbreak effecting the community. Being one of only 12 jurisdictions to be selected for the IEMC resident course was an honor and help to continue building on the partnerships with our EOC team while at the EMI campus.”*

### Does FEMA offer NIMS Certifications?

FEMA does not offer a “NIMS certification” as such. Each course issues its own certificate. Emergency managers and response personnel are required to have the amount of training that is appropriate to what their level of responsibility will be during an event. You should contact your employer or organization for further information on the courses that they may require.

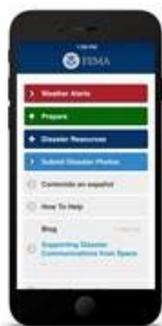
