# **EMI Hosts the 2023 National Preparedness Symposium**

**EMI recently hosted the 2023 National Preparedness Symposium.** More than 250 emergency management training, exercise, and planning officials from Federal, state, local, tribal, and other FEMA partners attended the event, which was held May 23–25 at the National Emergency Training Center campus in Emmitsburg, Maryland.

The National Preparedness Symposium provides an opportunity for participants to collaborate, share best practices, and receive information on guidance, tools, and resources, and discuss current and future programs and initiatives.

The Keynote address featured Victoria Salinas, Senior Official Performing the Duties of Deputy Administrator for Resilience. During her remarks, Ms. Salinas cited that preparedness requires constant vigilance, and that training and planning are cornerstones to keeping communities resilient.

FEMA remains committed to collaborating with our partners and doing our part to provide tools to support preparedness, response, and recovery for communities with diverse needs.

## **News from the EMI Branches**

### Preparedness:

National Qualification System (NQS) notes from the National Preparedness Symposium: FEMA's National Integration Center (NIC), EMI and several State Training Officers presented information on NQS implementation during the Symposium at EMI May 23–25, 2023. Some key takeaways from these presentations are provided here for those readers that were unable to attend.

The NIC and EMI delivered presentations on NQS development and on Training for NQS. Key take aways from
these sessions were the linkage of the training and tools to implementation and the NQS implementation timeline.
 NQS implementation guidance gives States until 2024 to develop an implementation plan and begin issuing
Position Task Books (PTB) for their deployable positions, with these efforts continuing into 2025. It was

emphasized that States utilizing a recognized qualification system such as National Wildland Coordination Group (NWCG) or All-Hazards Incident Management Team Association (AHIMTA) are already following the intent of NQS implementation guidance.

- A panel discussion led by the States of New York, Minnesota and New Hampshire outlined their diverse approaches to NQS implementation. Some common advice from the presenters included:
  - Start small. Many of the states started NQS implementation with their EOCs before expanding it to other deployable resources.
  - Get leadership buy-in early on for the importance of the implementation efforts and linkage of NQS implementation to EMPG funding.
  - Link the work you have already done on position qualification to NQS implementation. If you are already using
    a system, correlate this to NQS standards and utilize recognition of prior learning to qualify already trained
    and experienced personnel.
  - Find partners in other established programs such as adjoining States, the NWCG, U.S. Coast Guard, and the AHIMTA. Other organizations with established position qualification programs can be of great assistance in helping your State with NQS implementation.

#### Mitigation:

**Building Science:** The **E0279 Retrofitting Floodprone Residential Buildings** course scheduled for September 11—14, 2023, at EMI has been canceled. In FY24 the Regions will be able to request L offerings of this updated course. Hazard Mitigation Planning: The FEMA Mitigation Planning Program along with EMI has updated its local hazard mitigation planning training. The new Local Mitigation Planning Workshop course materials are available on the EMI G-course repository by State Training Officers. This instructor-led training reflects the Local Mitigation Planning Policy Guide (https://www.fema.gov/sites/default/files/documents/fema\_local-mitigation-planning-policy-guide\_042022.pdf) which went into effect April 19, 2023. The training covers the basics of mitigation planning for local communities. Through this training participants learn about the planning process, assessing risks, and developing and implementing effective mitigation strategies.

### **Integrated Emergency Management (IEM):**

**E0930 Community-Specific Integrated Emergency Management Course (IEMC):** On May 15–18, 2023, EMI hosted a Community-Specific IEMC for Pierce County, Washington, at the NETC in Emmitsburg, Maryland. The primary focus of this course was to address the potential of a Mt. Rainier eruption, triggering a lahar event. The course delivery appropriately coincided with Volcano Awareness Month.

More than 60 participants attended the course, including elected and senior officials, representatives from the Pierce County Department of Emergency Management, stakeholders from the Emergency Operations Center (EOC), public utility partners, the National Weather Service (NWS), and the United States Geological Survey (USGS). The course provided a comprehensive understanding of essential emergency management principles. This knowledge will empower these individuals to better prepare their community for future disasters.

Throughout the week, the participants engaged in three separate exercises, actively working through response and recovery scenarios. Discussions encompassed critical aspects such as evacuations, mass care, response activities, communications, debris removal, and recovery efforts. The goal was to equip the attendees with the necessary tools and strategies to effectively manage a community disaster situation before, during, and after its occurrence.

**FY2024 Master Exercise Practitioner Program (MEPP) Application Period:** The Master Exercise Practitioner Program is accepting applications until July 1. MEPP is designed for advanced exercise practitioners with 3–5 years of experience in HSEEP exercises. ### **Mission Support (MS):**

Do you like to teach? - E/L/K/G 0141, Instructional Presentation and Evaluation Skills, can use your skills! This course is a pre-requisite to teach other FEMA courses, or to obtain certain FEMA certifications. The E/L/K/G 0141 course is in high demand, and next year EMI will offer four classes on campus. EMI has instructors for three of the courses; however, we are in need. EMI needs instructors for the E/L/K/G 0141 courses next year, and in general, because currently there are only four instructors available. We don't want to over burden them or their program offices. Unlike many other EMI courses, instructors for E/L/K/G 0141 are NOT funded. Our E/L/K/G 0141 instructors are all volunteers. #### Ask a Course Manager

Recently we had students who completed G0300 and G0400 in our jurisdiction reaching out asking why their certificates were not being accepted by another state or jurisdiction. How can we ensure equivalency of our G certificates in other jurisdictions?

ICS-300 and ICS-400 are courses that are delivered by Authorities Having Jurisdiction (AHJ), managed primarily by: Federal Partners, Tribes, and States. It is up to each AHJ to determine equivalency of training certificates. The NIMS Training Program, released in May of 2020, provides guidance on equivalency, specifically on page 26. We, FEMA, recommend that AHJ include the date span of the course on their G certificates as well as the following verbiage: "This course was conducted in accordance with the NIMS Training Program (2020)". In addition, we recommend ICS-300 and ICS-400 not be delivered back-to-back and allow a reasonable amount of time between trainings for students to gain operational experience and understanding to further their knowledge, skills, and abilities in responding to expanding incidents. Focus Groups and SMEs from across the Nation determined that training was not being conducted to standard, and students were not prepared to be in ICS-300 and ICS-400 courses. Entirely too much time was being taken, during the delivery of these courses, to bring students up to par when they lacked operational experience. ICS-300 and ICS-400 are designed to give students skills to carry to the field, and without the experience, they lack the skills and knowledge needed to be successful. As part of this effort, the NIMS Training Program further recommends that anyone going to take ICS-300 should take ICS-200 in a classroom.

The intent of the NIMS Training Program, regarding the ICS-300 and ICS-400, is to ensure that the right people are taking the training, based on the knowledge, skills and abilities that are required to respond to expanding and complex incidents, and further within an Area Command Structure, or Multi Agency Coordination entity. Below are the excerpts of the selection criteria, for a quick glimpse, to help facilitate screening for students for the ICS-300 and ICS-400, helping to get the right people to the right training, based on their incident response roles, as well as the Incident Type and complexity.

**ICS-300 Selection Criteria:** Individuals who may assume a supervisory role in incidents. Note: During a Type 3 incident, some or all the Command and General Staff positions may be activated, as well as Division/Group Supervisor and/or Unit Leader level positions. These incidents may extend into multiple operational periods.

**ICS-400 Selection Criteria:** The target audience for this course is senior personnel who are expected to perform in a management capacity in an Area Command or Multi-Agency Coordination Entity.

# FEMA Regions Fiscal Year 2024 Planning Practitioner Program Application Review Process

#### Overview

- Applications have been received inside the NETC Online Application system
- Paper applications are no longer accepted
- Each FEMA Region will have 6-7 slots to fill
- Headquarter elements will NOT be included in regional slots (Example: FEMA HQ will not count toward FEMA RIII slots)
- Late or incomplete applications will NOT be accepted
- If you feel like you received an application in error (maybe wrong region, or a HQ element) send <u>james.greenshields@fema.dhs.gov</u> an email and we will get it corrected

#### **Timeline**

- Thursday, July 13 FEMA Regions receive their applicant packages via email and begin their review processes
- Strongly suggested that the RTMs work alongside the Regional Planning elements for selections
- Friday, July 28 FEMA Regions notify EMI of their 6-7 selected applicants (priority order)
  - Send your prioritized list of 6-7 applicants to <u>FEMA-EMI-IEMB@fema.dhs.gov</u> and <u>james.greensheilds@fema.dhs.gov</u> by July 29
- Early August Admissions works to put students in the two Cohorts
  - o Cohort FY24- 1 (E0237: Oct 16-20, 2023 & E0238: May 13-17, 2024)
  - o Cohort FY24- 2 (E0237: Nov 13–17, 2023 & E0238: Jun 10–14, 2024)
- August 15 Students are notified via NETC Admissions of the final decision

#### **Target Audience**

The Planning Practitioner Program series is designed for experienced individuals with significant responsibility in operational planning programs

- Applicants should have ongoing planning requirement within their current role (This is the MOST important criteria!) The Capstone will require candidates to work on planning assignments within their organization
- Applicants should have at least 3-5 years of experience in emergency management and/or planning activities
   the strength of package can be considered if this requirement is not met
- 75% or more job duties related to planning program -the strength of package can be considered if this requirement is not met
- Applicants should be well-versed in challenges related to planning process and conduct
- Whole community applicants with a specific planning program tie to their Emergency Management Agency
