Course Description:

K0051 Exercise Program Management is a basic-level course that provides a comprehensive overview of exercise program management. Participants will gain a better understanding of Exercise Program Management and create 'Take Home' documents. The course will discuss the facilitation of an Integrated Preparedness Planning Workshop (IPPW) and identify elements of the Integrated Preparedness Plan (IPP) as it relates to exercise program management.

The K0051 Exercise Program Management Workshop is delivered via a webinar format that includes classroom-like lectures, work-group activities, and a final test, to assess participants' knowledge gain. Additionally, work-group activities reinforce the concepts taught during lectures. K0051 courses are conducted online via Adobe Connect, in a one 4-hour block.

Participants must complete all 4 hours of this course and pass the post-test to receive full credit. Anything less will result in the participant's need to re-register for another course.
