FEMA Seeks Competitive Research Proposals to Advance Emergency Management

FEMA's Higher Education Program (HiEd)

(https://training.fema.gov/hiedu/?msclkid=41eac3c7ae9c11ec8bba3053684e7234) is seeking competitive research proposals to help advance the discipline of emergency management. The submission period closes at midnight ET on April 22.

HiEd annually funds academic research that examines complex real-world issues and provides actionable recommendations that advance the practice of emergency management. The program typically funds between 10-15 exceptional proposals under \$10,000.

To be considered for funding, proposals must:

- Come from individuals or teams currently associated with an accredited institution of higher education.
- Scoped for 3-9 months.
- Use the <u>Research Proposal Submission template</u>
 (https://training.fema.gov/hiedu/docs/hiedresearch/508_2022_hied_research_proposal_template.pdf) format for submission.
- Topics must be in areas related to climate change, equity, and/or emergency management higher education and professionalization.

To apply, send a completed template to fema-hiedproposals@fema.dhs.gov by midnight ET April 22.

Preparedness:

EMI Preparedness Branch seeks State Training Officer (STO) Input on updated Process for Train-the-Trainer (TTT) course applications; Incident Command System (ICS) and Position Specific. EMI Preparedness Branch is seeking State Training Officer (STO) input to update the process for Train-the-Trainer (TTT) course applications for both the National Incident Management System (NIMS) Incident Command System (ICS) and Position Specific programs. The new

process will mirror the process used by the EMI's Emergency Management Professional Program Advanced, and Executive Academies. The process will include a resume, proof of prerequisites, position credentials, deployment records, copies of Incident Personnel Performance Ratings and required STO or equivalent endorsement.

EMI Preparedness Branch releases L8585, Tribal Train the Trainer: The Tribal Curriculum section of the Preparedness Branch has released L8585, Tribal Train the Trainer, and is now accepting applicants for the first delivery in-person scheduled In Tahlequah, OK, June 6-10, 2022, with a virtual delivery (K8585) scheduled September 26 – 30, 2022. These will both be five full days of training. L8585 will cover the following courses: E/L/K 0580, Emergency Management Framework for Tribal Governments, E/L/K 0581, Emergency Operations for Tribal Governments, and E/L/K 0582 Resilience for the next 7 Generations: Mitigation and Recovery for Tribal Governments. Mitigation:

Hazard Mitigation Assistance - E0213 and E0214: Seats are available for E0213 Application: Review and Evaluation offering from July 18-19. This course will be held on the EMI campus. This course equips participants with the knowledge and skills required to effectively review and evaluate HMA sub applications and provide a general overview of how a subaward is issued. The ELK0212 Developing Quality Applications Elements course is a prerequisite for this course. Seats are also available for E0214 Project Implementation and Closeout offering from July 20-21. This course will be held on the EMI campus the same week at the E0213 class. This course will provide course participants with the knowledge and skills required to effectively implement and closeout a Hazard Mitigation Assistance grant project. Students must enroll in both the E0213 and E0214 classes to be eligible for the training.

Building Science - Building Science has a couple announcements for E0386 and E2460. There are open seats in both courses. Also, the E2460 course length has been increased from 4 days to 5 days. The **E0386 Residential Coastal Construction** course is scheduled for April 25-28, 2022, at EMI. The course is designed to train participants to effectively use and implement recommendations in the <u>FEMA P-55</u>, <u>Coastal Construction Manual (https://www.fema.gov/emergency-managers/risk-management/building-science/publications?name=p-55&field_keywords_target_id=All&field_document_type_target_id=All&field_audience_target_id=All).</u>

The **E2460 Advanced Building Science Series 1 Training** course is scheduled for May 9-13, 2022, at EMI. It was previously advertised as a 4-day course but was updated to be 5 days the week from May 9-13, 2022. The course addresses the ever-changing challenges faced from flood and wind risk through a comprehensive approach of best-practice mitigation, code compliance, designing for future conditions, and FEMA policies and funding mechanisms aimed at achieving higher standards.
